Minutes from last meeting:

Pool Report:

- Agreement was drafted between Blue Fins Swim Team and Forest Park HRA in order to determine fees from family pool memberships. We made an update to ensure membership fees are set to at least the cost of FP homeowner dues.

Beautification Report:

Pruning trees on Dry Creek has still not been determined. Discussed whether we should

because this section of land from the fence to the sidewalk is currently under the homeowners jurisdiction. If the board assumes responsibility now, we are concerned we will
continue to have this responsibility.

Social:

This could be another unofficial Forest Park social event. This year's Halloween seemed really quiet and dead, so this might make it more fun.

Communications:

Old Business:
